


NOMINATIONS AND ELECTIONS

Section 19 (1), 20, and 21 of the Constitution

The offices, including the committees, shall remain the same.

By July 15 of the year of the Supreme Council Session, the Chairperson of the Supreme Council Executive Committee shall appoint a Committee on Nominations consisting of four Supreme Council Session members (current or past), representing the diversity of our Order, plus the Supreme Regent, who will serve as chairperson for the purpose of developing a slate of officers for the ensuing Supreme Council Session. It is suggested that an announcement of this appointed committee and the nominations procedure be included in the "CALL" to the Session and in the Spring Edition of the Bulletin.

At the REGISTRATION DESK on OPENING DAY of the Supreme Council Session a list of the Nominations will be distributed to the representatives. It is recommended that a brief biography of not more than 75 words for each nominee be included.

On THE SECOND DAY of the Supreme Council Session additional nominations may be made from the floor. All those being nominated shall have been contacted by the member making the nomination in order to insure that those being nominated are willing to have their names on the slate. A bio on each nominee of not more than 75 words would be helpful. (A resolution will be presented at the beginning calling for nominations on the second day).

On THE THIRD DAY of the Supreme Council Session, printed ballots including the names of all nominees shall be distributed. In the case of the Line Officers and the Executive Committee, there must be individual ballots (unless the Constitution is changed), but the other committees may be elected on one ballot. Additional nominations will not be entertained at this time. Delegates will cast their votes, which will be counted by the two appointed tellers and the Judge of Elections, who will count the votes. (A resolution will be presented at the beginning to nominate and elect all Committeepersons and Trustees, collectively unless there is a contested election. In the case of the two Finance Committee Members, Supreme Trustees, Committee on Juniors and Committee on Appeals, if there are more than four nominees, the four receiving the highest vote will be declared winners).

THE NOMINEE with the majority of votes based on our established ratio between delegates and officers, shall win the election to his or her respective office. In the case of the committees, the required members for each committee with the highest number of votes shall be elected (the four Supreme Trustees, the three members of the Committee on Laws, the two additional members of the Finance Committee, the four members of the Committee on Juniors, and the four members of the Committee on Appeals).






IT PAYS TO LISTEN

Franklin Delano Roosevelt was often bored by the tedious small talk he was forced to endure and participate in at various social functions during his political career

One reason: He felt no one was really listening to anyone. Sometimes he liked to play a joke to make his point: when

someone greeted him, he would reply in a casual voice, "I murdered my grandmother this morning."

Often, he said, he was met with a polite, noncommittal response proving the other person wasn't listening. One day, however, he met an attentive listener. The calm reply? "I'm sure she had it coming to her."

GIVE YOUR KIDS SOME EXTRA SCHOOL HELP



Lots of children need special help in school. Here are a few ways you can help your kids develop skills that will help them in the classroom:

- **Help your child become organized.** Have a place for books, papers, pencils, and other study materials, and require that everything always gets put back where it belongs. Establish routines for daily study and homework, and

provide work charts or checklists as reminders for complicated tasks.

- **Repeat learning experiences.** Don't assume that your child has learned a skill or task, such as spelling a word or tying shoes, just because he or she managed it one time; an hour later he or she may seem to have forgotten it completely. Repeat directions, perhaps using different words.

- **Work with the school.** Request conferences with the teachers. They'll inform you about their methods, which you can reinforce at home.

ANNUAL FETE DES ROIS

Royal Arcanum ACA St. Rosaire Council #24 held its Annual Fête des Rois on January 5, 2014 at the Century House Inc., Acushnet, MA. Over 200 people attended from Massachusetts, Rhode Island and Connecticut. Our council has been involved in preserving French culture since its inception. The organization addressed the needs of the French Canadian community which was formed as early as the mid 1860's in this area. Several observances are held annually, but one which always stands out is the "Fête des Rois", the feast of the Three Kings is named after the three wise men who, according to tradition, travelled from the Orient to find the lowly stable in Bethlehem and pay their respects to the new born Christ child. Guided on their difficult journey by a wondrous star, they brought gifts of gold, frankincense and myrrh.

In France, the celebration of the feast forms the basis of the traditional Epiphany celebration, formerly celebrated on January 6th, and now celebrated on the first Sunday after New Year's Day. To mark the occasion, statues of the three kings are placed in the Nativity scenes or "Crèches", and a special cake is served after lunch or dinner. Children take special pleasure at the sight of the exotic figures of the Magi, but the high point of the day is when the Epiphany cake is brought out and the accompanying ceremony begins.

The cake is divided into pieces and distributed to all the "convives". In breathless silence, each person taste his or her piece of cake, keeping an eye on the neighbor, until one of the assembled company proudly displays the "bean" and is proclaimed "King", or a "pea" to be proclaimed "Queen". The King and/or Queen are crowned with a gilded and decorated circlet of some sort.

This feast has been celebrated throughout the Ages. Melchior, Balthazar and Gaspar are said in legend to represent the three races of mankind which were descended from the three sons of Noah. Their feast

day is, according to historians, a holdover from a pagan holiday picked up along the way the medieval custom of choosing a king to reign over the festivals.

The first reference to a "galete des rois" was in a French document in 1311. Louis III Duke of Bourbon, who died in 1419, is said to have chosen as "king" the poorest child in the realm.

Sixteenth century chroniclers recorded an Epiphany celebration at the Chateau of Romorantin, north of the Loire River, where Francis I "joyfully found the bean on January 5, 1521."

In the 17th century, a diarist mentioned the celebrations at the court of Louis XIV. In 1711 the baking of the Epiphany cakes was outlawed because of famine. During the French Revolution, the "galette des rois" became the "galette de l'egalite" by Revolutionary


decree. The cake reappeared on French tables with its proper name and still does to this day.

During our event, the Fleur de Lis Band provided French Canadian favorites and Collette Fournier called Quadrilles. Following the tradition, people brought their personally decorated Gigueux (limberjacks) and spoons. As always, there was a great amount of audience participation. There was a surprise visit from fiddler Daniel Boucher, a composer of Québécois fiddle tunes and a fine singer of traditional songs. Several vendors attended the event with Franco American books, cd's and genealogy information.

The theme this year was the Fille du Rois and the photo above is of Jennifer Avery dressed as a fille du rois and Regent Raymond Patnaude, dressed as a coureur de bois, shown distributing chocolate Fleur de Lis to the attendees.

REFLECTIONS ON DIETING AND WEIGHT LOSS

DiETING in America is a multimillion dollar business! According to L. J. Scutchings, we spend more than thirty billion dollars annually on dieting. No wonder dieting is such a profitable business, and likely to remain such, because the sad truth is that there are very few overweight people who lose weight and actually keep it off.

Americans are more overweight than ever! The Center for Disease Control and Prevention estimates that more than 66% of Americans are overweight or obese. A person is considered obese when his or her body weight is 20% more than the normal body weight.

As one who has fought the weight problem for most of my adult life and been on many different diets, I am the first to admit that losing fat and keeping it off is not an easy task. Scientists assure us that diet and exercise do matter in taking off the pounds, but recognize that environmental influences alone do not determine an individual's weight. Body composition is also informed by DNA and monitored by the brain. The brain exerts astonishing control over a person's weight and how much individuals eat. "Physical mechanisms keep us from losing weight," says Dr. Matthew W. Gilman, the director of the obesity program at Harvard Medical School. It is harder for some people to lose weight than others.


Most people do not realize that a 20-minute walk only burns up about 100 calories. Since there are 3500 calories in a pound, that means that in 35 days, a dieter might lose one pound. Obviously this could vary according to the speed of one's walk, and there is no doubt that moderate exercise is very beneficial to one's health; but when it comes to exercising as a means of taking off pounds, I think we get the point.

Most of the main types of diets are variations of the following: low-carbohydrate diets that are very high in proteins and fats; low-fat diets which reduce calorie consumption; and low-calorie diets, where the dieter consumes less calories each day

than are needed to maintain his or her body weight.

Being overweight is certainly not healthy. Some of the health complications that may accompany a weight problem are high blood cholesterol, high blood pressure, coronary heart disease, diabetes, certain cancers, and unusual stress on body joints.

What then is an overweight individual to do? Weight that is lost slowly tends not to come back quickly. Dieters should set realistic goals, such as losing ten per cent of their body weight in six months; then when the goal is obtained, continue whatever is working. Dieters must be aware of the simple fact that fat is burned off by consuming less than the required caloric intake to sustain one's daily weight. Let's be aware of our daily required caloric intake, and consume fewer calories than required each day.



Splurging on the food we enjoy one day a week might be a great idea. We should be sure to get a moderate amount of daily exercise. We also need to try to do some self-analysis in discovering why we eat the wrong foods, why we over-eat, and what situations incite us to indulge. Do we use food to comfort us when we are upset or reward us when we have been successful? Do we take time to savor the flavor of the food, or do we eat quickly because we feel the need to feel full? Are we bulk eaters? Dieters usually need to slow down their eating because it takes about twenty minutes for the brain to realize that our stomachs are full and give us that satisfied feeling.

Finding a friend or friends with whom to diet is often a good idea, as understanding, non-judgmental support is essential. Losing weight is not easy and requires patience, endurance, willpower, and commitment! Finding the appropriate solution to taking off pounds varies, and what works for one of us may not work for the other!






CUT YOUR ELECTRIC BILL IN THE SUMMER

How do you keep your energy bill from skyrocketing? Here are some suggestions

Summer will be here before you know it, along with the hum of the air conditioner cooling your house while draining money from your wallet. How do you keep your energy bill from skyrocketing? Here are some suggestions:



- **Look toward the light.** Switch to dimmers: they can save about 50 percent over standard light switches. Replace your incandescent bulbs with fluorescent light. And don't forget to turn off lights if you're going to leave a room for more than 10 minutes.



- **Invest in ceiling fans.** You could cut cooling costs by up to 80 percent if you use them instead of running the air conditioner constantly. Using them in conjunction with an air conditioner lets you raise the thermostat between 2 and 6 degrees. Every degree can help save 4-8 percent on cooling costs.

- **Lower the temperature of your water heater.** Most folks have them set at 140 degrees. Water will still be hot if you lower the temp to 110 or 120 degrees.

Another trick: Drain a few gallons of water from the tank every month. Sediment can gather, which makes the heating element work harder.

WANT TO GET SMARTER? WATCH WHAT YOU EAT

Want to increase your brainpower? Cybernetic implants aren't the answer (except in science fiction stories), but some foods may actually help your brain work better. No guarantees, but try some of these mental boosters:

- Walnuts. A Spanish study found that people who eat a small handful of walnuts a day saw their memory improve by 19 percent.
- Coffee. It helps you wake up, and a British study suggests that just 20-30 milligrams of caffeine (less than one cup) can enhance mental agility.



- Spinach. The magnesium in Popeye's favorite food may not make you instantly stronger, but it can increase the blood flow to your brain along with the rest of your body—at least according to a Japanese research team.
- Mussels. Seafood is considered brain food, right? Mussels provide high levels of vitamin B12, which can help insulate your brain cells as you age.
- Asparagus. Eating your vegetables is good for you. Asparagus is packed with folate, which can decrease the risk of depression.

It's an exciting time of year in Boston as we continue to march into spring. Our Insurance operation steadily increases in production, which in-turn increases our membership. One of our goals as a Fraternal Order is to increase our membership, which is a direct reflection on our insurance production. To do so, we generate Life Insurance Policies and Annuities from insurance agents as well as from member recommendations.



On February 27th, I visited the Massachusetts State House to testify on behalf of Bill H3542, which will allow us to amend our investment structure as a Society. Our Society has certain restrictions that we face being a Fraternal Order domiciled in the state of Massachusetts. The current Bill restricts our ability to gain a better return on Investments, which is the reason why I requested an amendment of the Bill. I urge every member to write a letter in support of this Bill to the Massachusetts State House. A WORD FROM THE SUPREME SECRETARY

Frequently I meet people who ask me, "What is Royal Arcanum?" I usually respond that we are a fraternal benefit society. Fraternal benefit societies are not-for-profit membership organizations that have a representative form of government and are organized through a lodge system (we call them councils) to carry out social, educational, charitable, benevolent, moral, fraternal, or patriotic endeavors. Fraternal provide members with life insurance and other financial protection benefits in accordance with state law and use the earnings to fund member-supported community activities. Fraternal are chartered by state law and have been exempt from income tax under Section 501 (c) (8) of the US Tax Code since 1909. In June 2014 the Royal Arcanum will celebrate 137 years as a family fraternal and notably continues the tradition of service to our members and our communities.

In this spring edition of our Royal Arcanum Bulletin, you'll read about many of the activities that our Councils provide throughout the United States and Canada. One area that our society is committed to and for which we are very proud is our educational support to students. Each year the Royal Arcanum awards over \$50,000 in scholarships and grant awards. We also maintain a low cost educational loan program for eligible members; last year more than \$42,000 was granted through this program.

Another way the Royal Arcanum serves and gives back to our members is by distributing our earnings in the form of dividends. We have continued this practice continuously since 1946 and this past year over \$175,000 in dividends was distributed to qualified policy holders.
